

NOTICE OF ADOPTION OF ORDINANCES

PAW PAW TOWNSHIP VAN BUREN COUNTY, MICHIGAN

TO: THE RESIDENTS AND PROPERTY OWNERS OF PAW PAW TOWNSHIP, VAN BUREN COUNTY, MICHIGAN, AND ANY OTHER INTERESTED PERSONS:

PLEASE TAKE NOTICE that the following is a summary of Ordinances No. 279 and 280 which were adopted by the Paw Paw Township Board at a special meeting held on March 17, 2022.

ORDINANCE TO AMEND RECREATIONAL (ADULT USE) MARIHUANA ESTABLISHMENT ORDINANCE – ORD. 279

SECTION I AMENDMENT OF SECTION IV, RECREATIONAL (ADULT USE) MARIHUANA ESTABLISHMENTS ORD. 276. This section amends Section IV regarding the number of recreational (adult use) marihuana establishments authorized in the Township, which shall include: zero Class A growers; not more than 4 Class B growers; not more than 16 Class C growers; not more than 1 excess grower; not more than 2 processors; not more than 3 retailers; not more than 2 total microbusinesses (regular or Class A), not more than 3 secure transporters; not more than 2 safety compliance facilities; zero marihuana event organizers; not more than 2 temporary marihuana events; zero designated consumption establishments. No other licenses as may be established by Administrative Rules are authorized in the Township.

SECTION II SEVERABILITY. The provisions of this Ordinance are severable.

SECTION III REPEAL. This section provides for repeal of any conflicting ordinances or parts of ordinances.

SECTION IV EFFECTIVE DATE. This Ordinance shall take effect upon publication after adoption.

ORDINANCE TO EXTEND AND EXPAND A TEMPORARY MORATORIUM ON MEDICAL AND/ORRECREATIONAL (ADULT USE) MARIHUANA GROWS – ORD. 280

SECTION I FINDINGS. This section includes findings supporting imposition of a limited moratorium on medical and/or recreational (adult use) marihuana outdoor grow operations in the interests of the public health, safety and general welfare. This section includes a list of 7 Township licenses for adult use and/or medical marihuana facilities/establishments that are exempt from the moratorium.

SECTION II TERM OF MORATORIUM. A limited moratorium on medical and/or recreational (adult use) marihuana grow operations, with certain exceptions, is extended through December 31, 2022 or until the effective date of amended or new Township ordinances and regulations addressing the location and approval process for these uses.

SECTION III EXTENSION OF MORATORIUM. The Township Board may extend the moratorium by resolution. Such extension must be published on the Township website.

SECTION IV SEVERABILITY. The provisions of this Ordinance are severable.

SECTION V REPEAL. This section provides for repeal of any conflicting ordinances.

SECTION VI EFFECTIVE DATE. This Ordinance shall take effect upon publication after adoption.
