## a. Master Plan Discussion.

The Planning Commission discussed the November 13 Master Plan Open House. The general thought was that a secondary open house should be planned for early 2025, but it would be very important to ensure that increased public notice efforts occurred prior. For instance, direct mailing postcards could be an effective way to get the word out. The Planning Commission felt that a February time frame might be ideal. The importance of the round table discussions was mentioned and Learned mentioned that it was also important to ensure we received input from the general public in addition to these special interest groups.

The group also generally discussed the feedback from the farming roundtable group, which included feedback on farmland preservation priorities, minimum lot sizes, and cluster development.

### b. Solar Ordinance Discussion.

The Planning Commission felt that the decommissioning bond requirement be reassessed by the Township attorney. Learned felt that a five-year interval for bond amount reassessment for the first 10-15 years might be ideal, with annual intervals after that time.
